Lecture Topic: Survival of the Fittest: Outcomes of Non-Surgical Endodontic Treatment

#### Lecture Synopsis:

This lecture will discuss how the ever-evolving landscape of specialized endodontics has influenced treatment outcomes of non-surgical root canal therapy. The lecture will also consider how non-clinical factors, such as clinician decision-making, influence the ability of endodontists to save the natural dentition.

Learning Objectives: At the conclusion of this lecture, the participants should be able to:

1. Describe how reported non-surgical endodontic treatment outcomes have changed over time.

2. Identify the most significant factors contributing to the prognosis of non-surgical endodontic treatment.

3. Consider how non-clinical factors impact endodontists' opportunities to save natural teeth.

Bio:

Dr. Lorel Burns is a Diplomate of the American Board of Endodontics. She is an Associate Professor of Endodontics at New York University (NYU) College of Dentistry and engages in part-time private practice in New York. Dr. Burns earned her DDS degree at NYU College of Dentistry (2015), completed her specialty training in Endodontics at the University of Pennsylvania School of Dental Medicine (2017) and was awarded her master's degree in clinical investigation by NYU School of Medicine (2019). Dr. Burns is a clinician-investigator, and her endodontic research program focuses on clinician decision-making, endodontic treatment utilization and outcomes, and oral health policy evaluation. Her research has been funded by the National Institutes of Health (NIH)/ National Institute of Dental and Craniofacial Research (NIDCR), the Robert Wood Johnson Foundation (RWJF), and the American Dental Education Association, ADEAGies Foundation. Her research findings related to endodontic topics have been published in the Journal of Endodontics (JOE), the International Endodontic Journal (IEJ), the Journal of the American Dental Association (JADA), the International Journal of Paediatric Dentistry (IJPD), and the Journal of Dental Education (JDE). Dr. Burns has been featured on the American Association of Endodontists (AAE) Endo Voices Podcast and invited to lecture nationally about her research on endodontic outcomes. In 2019, Dr. Burns was selected as the AAE Foundation's Endodontic Educator Fellow. In 2022, she was recognized with the American Dental Education Association (ADEA) Junior Faculty Award. She served (2023-2024) as the Oral Health Policy Fellow at the Centers for Medicare & Medicaid Services (CMS).
