Speaker: Jennifer L. Gibbs, M.A.S, D.D.S., Ph.D.

Lecture Topic: The neurobiological foundation of endodontic treatment planning and diagnosis.

#### Lecture Synopsis:

We will review how understanding how the sensory nervous system works can provide insights into endodontic diagnosis and treatment planning. This included the conundrum of persistent post treatment pain, how neuronal sensitization is what we are detecting when we perform routine endodontic diagnostic testing, and how central sensitization is related to odontogenic pain. We will also discuss biologically informed strategies to reduce the risk of persistent pain after routine surgical and non-surgical endodontic treatments.

Learning Objectives: At the conclusion of this lecture, the participants should be able to:

1. Explain how sensitization of sensory neurons influences endodontic diagnosis.

2. Identify strategies to reduce the risk of persistent pain after surgical and non-surgical endodontic treatments.

3. Understand how the unique innervation of the dental pulp complicates endodontic diagnosis.

## Jennifer L. Gibbs is Director of the Endodontics Division and Program Director of Advanced Graduate Education Program in Endodontics and an Associate Professor at Harvard School of Dental Medicine. She received her dental degree and her Ph.D. in Pharmacology from the University of Texas Health Science Center San Antonio. She then completed a certificate in Endodontics and an M.A.S. in Clinical Research from the University of California San Francisco, as well as a postdoctoral training period. She is now a full time faculty at Harvard School of Dental Medicine and serves as Director of the Division of Endodontics and Program Director of Advanced Graduate Endodontics at HSDM. She is a diplomate of the American Board of Endodontics. Dr. Gibbs heads a translational research group focused on understanding the neurobiological mechanisms of orofacial pain with a focus on dental pain, and patient centered outcomes of endodontic treatments. She teaches clinically in the advanced graduate

Endodontic Program, and at Boston Children's Hospital. Dr. Gibbs provides endodontic care for patients in private practice. She is a past Educator Fellow of the American Association of Endodontics and was recently recognized by the International Association for Dental Research with a Distinguished Scientist Award in Pharmacology.
